

# COOKIE POLICY

*Applicable from 29 September 2022*

## **1. Processing of personal data by using cookies**

- 1.1. This website uses cookies which may lead to the processing of personal data. We, therefore, recommend that you read our [privacy policy](#), which describes our processing activities and your user rights.

## **2. What is a cookie?**

- 2.1 A cookie is a small data file that is saved on your computer, tablet or smartphone. A cookie is not a program that can contain harmful programs or viruses. A cookie cannot collect information which is on your device, such as your name, who you are, residential information or accounts on the device.

## **3. The website's use of cookies**

- 3.1 Cookies are necessary for the website to function. Cookies help us get an overview of your visit to the website so that we can continually optimise and adjust the website to your requirements and interests. For example, cookies remember what you might have added to a shopping cart if you have previously visited the page if you are logged in and what languages you want to be displayed on the website. We also use cookies to target our advertising to you. On a very general level, cookies are used as part of our services to show content as relevant as possible to you.
- 3.2 On the website cookies are placed by .legal A/S and third parties – third-party cookies.
- 3.3 Two types of cookies are placed:
  - Session cookies, which are stored on your device until you close your browser.
  - Persistent cookies that are stored on your device for a longer period of time. When you return to the website, the cookie is automatically renewed.
- 3.4 Prior to your consent, we set two necessary cookies in your browser, which do not contain personal data. In addition, we do not set cookies without your consent. The two cookies we set are `__cf_bm` and `__Cfruid`.

3.5 `__cf_bm` is a necessary cookie that identifies and limits automated traffic, to protect the website from bots. This cookie expires after 30 minutes of continuous inactivity. The cookie is generated independently by Cloudflare and does not correspond to a user ID or other identifiers in your web application.

3.6 `__cfuid` is needed to manage incoming traffic and to get a better overview of the type of incoming traffic to avoid bots.

3.7 To see the specific cookies that .legal use on the website, click on the cookie icon down in the left corner and click on "Show details". Under each of the sections below, you will see the specific cookies by unfolding the arrow.

▼ <b>Statistiske</b>	Vi indsamler oplysninger om, hvordan du interagerer med hjemmesiden, herunder hvor ofte du besøger siden, og hvilke sider du kigger på. Det gør vi for at kunne optimere design, brugervenlighed og styrke effektiviteten af hjemmesiden. Derudover bruger vi oplysningerne til at give dig personaliseret indhold og udarbejde markedsanalyser.
▼ <b>Marketing</b>	Vi indsamler oplysninger om dine interesser, herunder hvilke sider og annoncer du klikker på, hvilke produkter eller ydelser du viser interesse for, eller køber, på denne og andre hjemmesider. Det gør vi for at kunne vise dig annoncer, der er relevante for dig og dine interesser. For at kunne vise dig målrettede annoncer på denne og andre hjemmesider, samarbejder vi med andre virksomheder, som vi deler oplysninger med. Det kan du læse mere om herunder.
▼ <b>Uklassificerede</b>	Uklassificerede cookies er vi i færd med at klassificere sammen med udbydere af de enkelte cookies.

#### 4. How long are cookies saved?

4.1 How long cookies are saved on your device can vary. The time when they are scheduled to expire is calculated from the last date you visited the website. When cookies expire, they are automatically deleted. You can view a complete list of cookies below.

#### 5. This is how you can reject or delete your cookies

5.1 You can always reject cookies on your computer, tablet or phone by changing your browser settings. Where these settings can be found depends on the type of browser you are using. If you do change the settings, please be aware that there will be some functions and services that you cannot use because they rely on the website being able to remember the choices you have made.
